On behalf of the Director-General, I am pleased to invite you to attend the first meeting of the Interim Committee for the Information for All Programme, to be held at UNESCO House, Paris, Room VIII (Fontenoy Building, 14-15 May 2001, 10 a.m. - 6 p.m.).

As you are aware, the Executive Board requested that the Interim Committee, created under 30 C/Resolution 36, fulfil the functions of the Intergovernmental Council for the Information for All Programme until the election of its members by the 31<sup>st</sup> session of the General Conference.

I should like to point out that, according to Article 9 the Statutes of the Intergovernmental Council for the Information for All Programme, adopted by the Executive Board at its 160<sup>th</sup> session (160 EX/Decision 3.6.1) "Member States shall bear the expenses of the participation of their representatives in sessions of the Council, its Bureau and working groups with the exception of representatives of Least Developed Countries (LDC) whose expenses shall be covered by an appropriation voted for this purpose by the General Conference of UNESCO."


